### **Aetna Better Health® of Florida**

Behavioral Health Integration - March 1, 2022

Please be advised that as of **March 1, 2022**, Aetna Better Health of Florida (ABH-FL) is no longer contracted with Beacon Health Options (Beacon) for the management of ABH-FL members' behavioral health services.

Effective March 1, 2022, ABH-FL transitioned to an integrated medical and behavioral management model and will contract with **Behavioral Services Network (BSN)** for its behavioral health and substance abuse provider network. Through this new approach, ABH-FL will be handling behavioral health clinical and operational functions, including care management, utilization management, and claims. Incorporating behavioral health into our current infrastructure improves efficiencies between the health plan, providers, and enrollees.

### **Continuity of Care Reminder**

Enrollees will not experience an interruption in service(s) or care coordination. Aetna Better Health of Florida <u>WILL HONOR</u> any ongoing treatment that is currently being provided or that was previously authorized by Beacon for the duration of the authorization or up to 60 days, whichever is first, following the transition on March 1, 2022. Continuity of care applies to Aetna Better Health of Florida participating and non-participating providers. After 60 days, authorizations will be required for non-participating providers to continue rendering services to Aetna Better Health of Florida members.
